1. Chairperson Note

We feel proud that we have been successful and instrumental in changing the lives of thousands of rural poor, SC/ST and deprived people as well farmers, landless, women, youth and children. Our focus on the thematic areas of 'Livelihood Promotion to address the poverty, Gender and Social justice, Natural Resource Management- Agriculture, Forests and water; and Responsive Governance' remained as earlier. This year maximum planned efforts of SGVS were on 'family as unit'. Convergence of government schemes was one of the main operational strategies we adopted. Direct participation of the direct constituency groups also is another operational strategy we adopted in our work as usual. New initiatives in new villages through JNPT & IWMP projects like in situ Soil and water conservation work are giving us concrete results on the ground. Thousands of women and youth helped themselves to create new avenues of livelihood in rural Vidarbha under facilitation of SGVS.

The overall situation with regards to the voluntary development sector has been rapidly changing. International Foreign Funding Organizations are withdrawing from India. Recognition of the sector's contribution in development also is at stake. New avenues of corporate funding are in totally confusion. It is very difficult to get committed and capable human resources. Earlier staff in this sector is leaving as they get better options in Government promoted NGOs and CSR and creating huge gap in this sector. Many of the funding partners are changing their track and wish to work directly in the field. Thus the sector is facing sustainability issue and so SGVS too. SGVS, fortunately, is able to continuing with its efforts and strength at ground level

work. SGVS also is engaged with many such processes at state and national level and so has the good rapport with many actors in this field. SGVS could generate financial resources through general donations and approaching to individuals and new development partners. I am proud of the Governance of SGVS who keeps me guided every time and gives strategic inputs. Our existing staff is capable and committed and cooperating whole heartedly. I thank all of them and the individual donors and all the project funding partners for their generous support. I also thank all our grass- root volunteers for their contribution and collaborating partners across state and Nation.

2. Organization Summary:

Vision statement -

Sadbhavana Gramin Vikas Sanstha (S.G.V.S) is a governmental voluntary organization founded by a group of persons inspired by the thought of Gandhian Philosophy, especially the problems of downtrodden population living in the rural area and their socioeconomic condition and upliftment of their livelihoods through the means and directives as contemplated in their imagination adding with the modern technology, developed during the recent period. It was registered in 1996 under Society act to the Govt. of Maharashtra.

Since its inception, our organization has implemented projects of low cost housing in the Slum areas of Wardha, women empowerment through SHG groups, organic farming under the package of State and Central Govt., drinking and raw water problem through Jal-Swaraj Project, Health Camp, mobile dispensary and other related activities.

Our organization has been identified as a Project Training Institution under the centrally sponsored Integrated Watershed Management Programme (IWMP) and functional in 25 villages for building capacities of different project level functionaries.

Our organization has also been shortlisted as a Project Implementing Agency for the IWMP project. The Government of Maharashtra has enrolled our name in the list of qualified and

capable organizations as per their indicators for scrutiny. Therefore we will get opportunity of implementing the watershed program with a livelihood development component. The organization has got opportunity to work with UNICEF, New Delhi for implementing Child Labor Campaign in Wardha block of Wardha district. The organization have working with state government of Maharashtra as an implementing agency for implementing Convergence of Agriculture Interventions in Maharashtra i.e. CAIM project in Wardha block that is specially designed for small, marginal farmers, landless and widows in distress in Western Vidarbha region of Maharashtra.



9. Outlook of organizational major activities/ achievement in past three years

The major activities conducted by SGVS in past three years are related to the sustainable agriculture, child labor /child protection/child rights &education, gender, social protection, rural development, in-situ soil and water conservation, watershed management, sanitation, public health & nutrition etc.

I. Govt of Maharashtra through District Superintending Agriculture Office, Wardha (2019-20)

Under Integrated Watershed Development Programme (IWMP) SGVS have been selected as District Resource Organization (DRO) for Wardha District. Under this project various training activities such as livelihood resource agency (LRA) for district. Under this programme organization have aiming to provide guidance and trainings on livelihood aspects to the SHGs, User groups, small entrepreneurs etc. these trainings were specially emphasizing this community on how to generate small and micro entrepreneurships in villages related to production, packaging & marketing of produce. They were also oriented on how to link bank for financial assistance etc

II. Corporate Social Responsibility (CSR) through Javaharlal Port Trust (JNPT), New Delhi

SGVS have undertaken the micro watershed development program having concept rain water Harvesting, conservation, storage & ground water recharge based on micro watershed development that has been funded through Jawaharlal Neharu Port Trust [JNPT] Mumbai under the Jalyukta Shiwar Abhiyan Wardha district Maharashtra state. Under this program watershed development work such as Nala deepening, Nala widening & drainage line treatment have carried out according to ridge to valley concept. The watershed development work has been carried out in Satoda, Mahakal , Bhankheda, Pujai & Dhanora villages in Wardha district of Maharashtra. There is around 1500 Ha area bought under micro watershed development

III. Govt of Maharashtra & International fund for Agriculture Development (IFAD) through District Programme Management Unit, Wardha (CAIM)

SGVS worked as an Implementing Agency (IA) for project named "Convergence Agriculture Intervention in Maharashtra" (CAIM). The project comprise of 23 Villages in Wardha Cluster targeting on Suicide prone zone Landless, small & marginal farmers, widows from distressed



Families. The major purpose behind implementation of this project is to provide end to end solutions to the community though (i) improving household incomes from diversified farming and from off-farm activities; (ii) render farming systems resilient with the introduction of organic and low-input contract farming; (iii) facilitate the involvement of farmers groups in primary processing, quality enhancement and marketing; (iv) empower women through micro-finance and micro-enterprises; and (v) achieve convergence of government programmes and resources.

IV. Integrated Watershed Management Program (IWMP) Project implementing Agency (PIA) for Jalna

IWMP project in Jalna district is carried out with great deal of enthusiasm. SGVS got selected SGVS undertook "Project implementation Agency (PIA) in Integrated Watershed Management Programme". (IWMP) Focusing on 8 villages from 6 major GPs from Jalna clusters from Jalna district. The major objective of this project is to generate agro based entrepreneurships in village for sustainable livelihood. Soil and water conservation work. Long term planning for resource based self-employment in village. To develop agro and non -agro based entrepreneurship opportunities for landless, labors, women & small and marginal farmers as a secured income source along with watershed development.
